Mayor Coleman called the meeting to order. Council Member Kowallis gave the invocation and the Pledge of Allegiance was led by Council Member McKee.

Council Member Kowallis reported that planning and zoning did meet last week and went over the manufactured home zone ordinance and that we will be having a public hearing on it in November. He also stated that they worked out the conditional use permit for B & C Auto Parts and Sales.

Council Member McKee reported water is good and they will be exercising valves the next couple of weeks. He reported the street department would be cleaning storm drains next week.

Council Member Miller asked if we were going to waive water overage fees this winter like we did last winter to encourage people to let the faucets drizzle to keep from having frozen meters and lines? It was discussed a little and decide to discuss it at the next meeting.
