Mayor Miller called the meeting to order. Council Member Bourne gave the invocation and the Pledge of Allegiance was led by Council Member Stay.

Council Member Bourne made a motion to approve the agenda. A second was made by Council Member Ogborn with all council members present voting in favor of the motion.

Mayor Miller stated the next item on the agenda was approval of the minutes.

Mayor Miller stated our next meeting would be on December 5th at 6:30 pm followed by the City Christmas party at 7 pm. He also stated that the women's civic club will be dissolving in January.
